## Content:

Environmental awareness is an incredibly important part of our lives. In order to protect the sustainability of the planet, everyone needs to commit to becoming more environmentally aware. This course is for any individual interested in enhancing their environmental footprint and their organisation's efficiency.

This 1-day course will focus on self-assessment and look at how to prioritise actions specific to organisational, leadership and management cultures within your organisation. The environmental Leadership Programme is designed to help develop knowledge, skills and networks to become a successful green leader and leave with a greater awareness of your own leadership strengths and developmental needs.

Unlike briefing events, which raise awareness and allow the company to fall back into inertia/procrastination, this programme incorporates an Environmental Action Plan.

Companies sending delegates on to the programme will be aware at the outset that the company will need to make arrangements for delegates to undertake an assessment and produce an Environmental Action Plan as part of the programme.

- The Environmental Action Plan will then be subject to review and recommendation at a virtual meeting with Brook Corporate Developments within 3 weeks of completing the training.
- The program will explore and generate commitment to the UK.gov SME Climate Hub

In addition, progress routes relevant to the company will be weaved into the programme and the review meeting for avenues like ISO14001 Environmental Management / BREEAM (Building Research Establishment's Environmental Assessment Method).

### Part 1 (AM):

- The main components of a green economy.
- Importance of environmental awareness within supply chain management
- Advantages and benefits of environmental management systems such as NetZero & ISO14001
- How environmental change is made on a local, national and global level
- Sustainability peer to peer discussions

### Part 2 (PM):

- The Environmental Action plan will cover scope 1 (direct) and 2 (indirect) emissions and the plan steps towards addressing scope 3 emissions (supply chain)
- Delegates should allow time for the development of the Environmental Action plan within 3 weeks of completing the course
- The company should allow time for the delegate to develop the Environmental Action plan within 3 weeks of completing the course
- Follow up one-to-ones will be scheduled prior to the course completing to support implementation
